NARFE’s Mission Statement is always on page four of the monthly magazine. The central theme is to support and promote legislation beneficial to its members.

The FONC was formed to come up with the best way to take NARFE forward within this theme. The original proposal was presented at the Orlando National Convention. Several of us on the Federation board went to the convention thinking there would be a big discussion of the ideas and some compromise reached. Not much discussion occurred, and the proposal passed with 85% approval to go forward and the promise members would be included in the decisions for the plan. This did not happen.

The plan the committee came up with will be presented at the national convention and is on the national website for us to review. The plan changes dramatically the organization of NARFE, but still stresses the need for continuing legislative efforts. Everyone agrees legislation is the most important issue we face. Each member should take a look and make your own assessment of the plan presented. The decision on our future is not an easy one. NARFE definitely has its financial problems, low membership, and lack of members who are willing to serve as officers in most of the chapters. Many chapters are closing from lack of participation.

I guess I don’t have a better plan to magically increase our numbers and have everyone want to serve as an officer. I do think either way we go there will have to

be active and realistic recruiting in addition to better communication of the need to continue the priority of contacting our representatives on legislative issues. Grass roots advocacy is still the most effective way of influencing Congress and keeping our issues on the forefront.

In my opinion, if we adopt the plan of the FONC committee, we will lose the best part of what we have now. That is, the NARFE members who take the officer positions in the chapters and are really concerned with protecting our benefits. In the chapters I have visited as Federation Legislative Chairman, there are always members who keep up with the latest activities in Congress and bring everyone up to date on the issues. A lot of these people are also at the Federation Convention

each year representing their members and taking back what they have learned. This idea for working within the present structure to accomplish the same goals (specifically the “State Representative and Congressional District Leaders”) was offered to the FONC and national officers by our past president Larry Henderson, but I haven’t seen any acknowledgement of consideration from the committee.

Understanding proposed changes is vital

I hope everyone is making plans to attend our Federation Convention in Pigeon Forge on April 25th and 26th. This is probably one of the most important Federation Conventions that you will ever attend. There

are a lot of proposed changes for NARFE, and it is vital that we all understand these changes.

NARFE National President Richard Thissen will speak at our Federation Convention via Skype and hopefully there will be time for a question and answer session. You may remember that a couple of years ago the Future of NARFE Committee (FONC) made recommendations for changes in the way NARFE does business. At the 2014 National Convention a resolution was passed to use those recommendations as the basis for a plan to ensure NARFE can continue its mission well into the future. National President Thissen subsequently appointed a Strategic Planning Committee (SPC) and a Strategic Planning Team (SPT) to use the 35 recommendations from the FONC as a basis to continue planning NARFE's future. At the November 2015 NARFE National Executive Board (NEB) meeting the draft strategic planning document was presented to the Board. The NEB considered this information in preparing resolutions to be presented at the 2016 National Convention in Reno in August. These resolutions are HUGE changes for NARFE. The strategic planning document is posted on the NARFE website. If you have not already done so, please read this document. Our Federation Convention will be a great opportunity

to hear more about the proposed changes and to ask questions. Our Region X Vice President Bill Shackelford, who is a member of the NEB, will be attending our Federation Convention. I have a lot of questions and hope to come away from the Convention with a better understanding of the proposed changes and the SPT recommendations.

As a reminder - The 2016 NARFE Scholarship Program runs through April 29. The program is open to eligible children, grandchildren, and great-grandchildren (including step children, step grandchildren, etc) of a current NARFE member. Applicants must be a high school senior planning to attend an accredited college full time in a degree program in the fall/winter of 2016 and have a grade point average of at least 3.0 on an unweighted 4.0 scale. The application and additional information is on page 47 in the March NARFE magazine. Sixty \$1,000 scholarships will be awarded to winners of this year's competition. Winners will be announced in August. With the high cost of a college education a \$1,000 scholarship could be very helpful.

I am looking forward to our Federation Convention and I hope to see a lot of you there.

It's time for an eye exam

If you can't remember the last time you had an eye exam, and it's been longer than a year, you are overdue. Eye exams are not just about vision.
