The Prez Says ...

Well another NARFE national convention has come and gone. Not much excitement. There were roughly 800 in attendance which is down a little from prior events.

National President Richard Thissen and National Secretary-Treasurer Jon Dowie were re-elected with no opposition as was Region Vice President William Schackelford.

There were 16 Bylaw resolutions to be voted upon by electronic ballot. The National Board was pushing three of them; two passed, one failed.

The Board was very excited about the passage of these two measures. I am not sure they will have much impact at the local level. One will make chapter membership optional. There are those in our midst that tend to believe this will be our salvation to membership decline. I am not one of those believers. Most members do not even know or care what the local dues are. They will join if they feel there is benefit for them. The same goes for attending chapter meetings. NARFE is experiencing the same attrition issues as most other organizations. When we lose a member either by death or lapse in dues payment there is not enough attention paid by the local chapter to

either get that member back or replace those who have passed on. I believe FERS implementation in the mid - 1980s had as much to do with membership drop as did chapter obligation. They both happened around the same time.

The other measure that passed dealt with voting procedures at the national convention. NARFE has operated on a representative form of governing for much of its history. This similar to the way our nation operates with Congress, except we actually pass a few legislative measures; not so with Congress. Now we will have one member, one vote meaning every NARFE member will have an opportunity to voice their personal opinion via mail or electronic ballot prior to the national conference. I doubt this will move people to be much more involved than they are now; much the same way our national electorate has a huge uneducated and non-participating voting block each election cycle. Those that are interested will get their information from articles in the magazine or on the website and vote accordingly without the advantage of hearing any debate (with the exception of some blogs).

The thing this measure will do is greatly reduce the size and scope of the biennial convention (to be called conference). There will be virtually no business conducted at these conferences,

Changes We Will See Hopefully Will Be Good Ones And Will Help To Strengthen NARFE

At this year's National Convention the National Executive Board (NEB) submitted three resolutions and two of those three passed. I believe the two resolutions that passed - the Optional Chapter Membership and One Member

One Vote resolutions - will bring about big changes in NARFE. I hope the changes that we see will be good ones and will help to strengthen NARFE. I have not seen any specifics on these changes - only general information. The NEB is meeting November 15 - 18 and these topics will be discussed. Hopefully we will receive something shortly after that with specific information about these changes and what we can expect in the future. And speaking of the National Convention - two of our delegates from Tennessee, Lynn and Carlos Henning from Jackson, are pictured in the November NARFE magazine in the article about the Convention.

Please remember that our Federation recruiting incentive awards that began July 1, 2016 continues through December 31, 2016. The Federation will give any member a \$10 incentive award who recruits a new member who joins between July I and December 31, 2016, up to the first 100 new members. Be sure your name and NARFE membership number (which you can find on the label of your NARFE magazine) are shown on the application so that you will receive credit for the recruitment. In addition, there is also a national NARFE membership drive from September I - December 31, 2016. Recruiters will receive \$10 from NARFE Headquarters for each member who joins between September I and December 31, 2016. Recruiters will also be entered into a monthly drawing for prizes and for a grand prize. Again - be sure your name and your NARFE membership number are shown on the application to receive credit for recruitment. This means when you recruit a new member who joins between September I and December 31, 2016 you will receive \$10 from the Federation and another \$10 from NARFE Headquarters. So get out there and start recruiting!! There is strength in numbers and we need NARFE to be strong in the fight to protect our benefits.

We had approximately 40 people representing five chapters in attendance at our Seventh Annual West Tennessee Joint Chapter Meeting which was held in Jackson on August 11th. There were three candidates (the nominee from the Democrat party and two Independents) for the eighth district Congressional seat who spoke at the meeting and then there was a question and answer session. Our members asked some very good questions. I think the candidates were impressed with the questions asked and the information that our members supplied to them regarding issues affecting federal employees and retirees. The nominee from the Republican party had a scheduling conflict and could not attend the Joint Meeting in August but he spoke at the Jackson Chapter Meeting in September. The incumbent for the eighth district is not running for reelection so this was a great opportunity for our members to meet and talk with these candidates, one of whom will likely be elected as our next Congressman.


Effect of Convention Changes Not Yet Clear

We Need Less Than \$10K to Meet Our Giving Goal Plus Coordinator Warns Against Bogus Christmas Card Scam

Our Alzheimer's National Association has a fiscal year ending on June 30, 2016. Our total NARFE Alzheimer's Research collection is \$11,889,336.18. We need \$9,566.68 to make our goal of \$12 million. The NARFE Alzheimer's Committee will allocate \$479,050.21 in research grants this year.

Our Region X had a total collection of \$110,453.08 of which Tennessee had \$6,470.40. As our fiscal year runs from January to December, our total is only for ½ year. What a great job our chapters are doing with their collection of donations, and the great support of the chapters when it comes to the Silent Auction at the Convention.

I know getting the donations is hard with so many competitions like the Tennessee Alzheimer's, and Pat Summit's Alzheimer's, but we all must remember that all of our donations go to research to end this terrible disease, and none of our

monies go to administration fees.

Not Much Is Happening But We Must Keep Vigilant

There is not much going on in the legislative department because of the election. The major issues though the summer have been: Postal reform, Long term care insurance, Windfall elimination provision, and the upcoming Medicare part B hold harmless provision.

Long term care insurance increases have increases averaging 83% and all I have seen are the steps taken to avoid like increases for the future. NARFE has called for hearings in Congress, but the process is still lacking in any control for future increases.

The WEP proposal is also still on hold after the late minute changes included reducing the WEP penalty applied to Social Security benefit from around fifty per cent to about fifteen per cent. NARFE opposed this change but still supports the bill in its original form.

Medicare part B problem is the same as last year in which Congress amended the law to spread the increase for all of us to avoid the unfair burden of increase on those who did not have Social Security coverage. Hopefully they will do the same thing this year when they come back

after the election.

Postal reform legislation still includes mandatory Medicare coverage for current postal retirees, which NARFE opposes.

A continuing resolution to keep the government funded

through December 9th was passed before Congress adjourned for the election recess, so appropriations consideration will resume when they reconvene November 14th, after the election. WE will need to remain vigilant for any future proposals that affect federal employees and retirees. So keep active and on top of what is going on so when our national office requests us to contact our legislator on an issue, we can let them know what we think. They do respond to our letters if we have enough members who take action!





Hotel Banquet and Meeting area.




Hotel rooms offer wi-fi and either two queen-size beds or one king-size bed.
